Special Remarks:

- 1) Candidates who enter their documents and information into the Fint (https://fint.firat.edu.tr/) system must also apply to the advertisement in the relevant system. Otherwise, the application will not be evaluated.
- 2) Necessary announcements will be made on the website of our University, and no separate notification will be made to the candidates who are eligible for final registration.
- **3**) Final registrations will be made in person and power of attorney will not be accepted. Students who do not make final registration within the specified time will lose their final registration rights.

APPLICATION CONDITIONS

- 1. Candidates to be accepted to graduate programs must be in the status of "foreign student" determined by YÖK. According to this; Those who have acquired the citizenship of the Republic of Türkiye as a second nationality, and those who have become a foreign citizen while being a citizen of the Republic of Türkiye, can apply for this posting.
- 2. Candidates who have received their undergraduate degree from higher education institutions abroad are required to have the higher education institution they graduated from be recognized by YÖK.
- 3. Candidates applying to programs in the fields of medicine, dentistry and veterinary medicine, pharmacy and health sciences are required to have an "Equivalence Certificate" indicating that the higher education institutions they graduated from are accepted as equivalent by YÖK.
- **4.** Graduates from undergraduate programs to graduate programs; For doctoral programs, applicants who have a bachelor's degree for at least ten semesters, excluding faculties of

medicine, dentistry and veterinary medicine, pharmacy and preparatory classes, and candidates who have graduated from master's programs with thesis are accepted.

- 5. Candidates applying to doctoral programs are required to get at least 55 points from foreign language exams accepted by YÖK or equivalent points from foreign language exams accepted as equivalent by ÖSYM. This condition is not sought for candidates whose mother tongue is the official language of their country or language of undergraduate education in one of the foreign language examination languages accepted by YÖK. Candidates who do not submit their foreign language documents during application or registration; Students who enroll in TÖMER for Turkish language learning in the same period are required to submit their foreign language certificate within the period of submitting their Turkish language proficiency certificate. If the documents are not delivered on time, the student is dismissed from the institute.
- **6.** The candidate must not have been penalized for a disciplinary offense from a higher education institution in Türkiye.

APPLICATION PROCESS AND APPLICATION APPROVAL

- 1. Applications will be received via https://fint.firat.edu.tr/ on the announced dates. Applications made by e-mail or post will not be processed.
- 2. The application information and documents uploaded by the candidates through the https://fint.firat.edu.tr/ system are reviewed by the Application Review Committee established by the relevant Institute and the applicants are approved for the application on the application system. This commission checks the recognition of the higher education institution from which the candidate graduated by YÖK and uploads the recognition certificate through the system.
- 3. In case the application information and documents are inaccurate or incomplete, additional time may be given to the candidate by the relevant institute directorate in accordance with the application and registration calendar to correct the error or deficiency. If the error or deficiency cannot be corrected in due time, the application is rejected and the candidate is dismissed from the institute even if he/she has been accepted to the program.
- **4.** Approval does not require admission to the program.

DOCUMENTS REQUIRED IN APPLICATION

- **1.** Final registrations will be made in person. Power of attorney will not be accepted during final registration.
- 2. The following documents must be uploaded to the system at the time of application.
 - a. Applying to graduate programs; The Turkish translation of the undergraduate diploma and the undergraduate transcript approved by the Turkish foreign representative offices or with a notarized copy and certified by the Turkish foreign representative offices or by the notary public,
 - b. Applying to doctoral programs; A copy of undergraduate and graduate diplomas, undergraduate and graduate transcripts approved by Turkish foreign representatives or notary public and Turkish translation approved by Turkish foreign representatives or notary public.
 - c. Passport sample.
 - d. Photo (must have been taken within the last six months).
 - e. Valid Turkish Language Certificate and Foreign Language Certificate, if any.
 - f. An Annotated Education Visa or a document proving that you are an international

- student who will not be required to obtain an education visa within the framework of the principles determined by the General Directorate of Security.
- g. For students who come with a state scholarship within the framework of bilateral agreements, a document stating that their fees will be paid during the registration period.
- h. Bachelor/graduate Diploma Equivalency Certificate from YÖK for the fields of medicine, dentistry, veterinary medicine, pharmacy and health sciences.
- i. **If the program is required as an application condition,** ALES, GRE or GMAT result document (ALES exam is valid for 3 (three) years, GRE and GMAT exams are valid for 5 (five) years.)
- **3.** If students who are entitled to final registration and given time due to missing documents do not submit their missing documents within the deadline, or if it is understood that they submitted false or incorrect documents during registration, their relationship with the institute will be terminated, even if their final registration has been completed.

EVALUATION OF APPLICATIONS

- 1. Candidates whose applications are approved by the Graduate School are notified to the departments/articles/program coordinators. The Candidate Evaluation Commission evaluates the applications, taking into account the provisions of the relevant directive and the conditions of the announcement.
- 2. In case of more applications than the announced quota, unless the program-specific conditions are specified in the announcement; Candidates applying to master's programs will be given priority according to their undergraduate graduation grade, and candidates applying to doctoral programs will be given priority from C2 level to B2 level according to the success points to be obtained by adding 70% of the graduate graduation grade and 30% of the foreign language grade. Sorted. The foreign language score of the candidate who does not have a foreign language score is considered zero. Those who have A-level Turkish Language Certificate are not given priority.
- **3.** As a result of the ranking, placement lists are created as candidates as the quota, and the others as substitutes. The Candidate Evaluation Commission evaluates the capacity of the program, the agreements between the countries to which Türkiye is a party, etc. may request an increase in the quota of the institute with justifications. In this case, up to 50%, by the decision of the EYK, and for more, by the decision of the Senate, the reserve candidates may also be given the right to register..
- **4.** If there is a written and/or oral exam requirement for a program in the announcement, these exams can be made remotely via online methods via audio and video communication tools, provided that they are recorded with the approval of the EYK.
- **5.** The application files of the candidates are finalized as stated below:
 - a) Acceptance: Candidates who are found successful by the Candidate Evaluation Committee and approved by the EYK upon the decision of the department / department / program executive board are directly accepted to the program.
 - b) Conditional Acceptance: Candidate Evaluation Committee, the candidate; The candidate may offer "Conditional Admission" for reasons such as the lack of a Turkish language certificate, the graduation area not equivalent to the program applied for, or the partial fulfillment of the ALES and similar exam requirements in the program application requirements, provided that the candidate makes up for these deficiencies within a certain period of time. According to this;

- Admission to Turkish Preparatory Program: Candidates who do not have a valid Turkish Language Certificate included in the application conditions are admitted to the "Turkish Preparatory Program" conditionally. Candidates accepted within this scope must obtain a valid Turkish Language Certificate at the end of two semesters at the latest. Students who cannot obtain a valid Turkish Language Certificate at the end of the given period are dismissed from the institute.
- Admission to the Scientific Preparation Program: Candidates who can be accepted to a postgraduate program other than the undergraduate program they graduated may be accepted to the scientific preparatory program by the EYK upon the opinion of the Candidate Evaluation Commission and the recommendation of the relevant institute department / department / program executive committee in order to eliminate their academic deficiencies and adapt to the program they have applied for.
- **Program Conditional Admission:** If ALES and similar exam conditions are included in the relevant announcement and the candidate does not meet this requirement, the candidate may be given a "Program Conditional Admission" with the decision of the EYK upon the opinion of the Candidate Evaluation Commission and the recommendation of the relevant institute department / department / program executive committee. These candidates can take a maximum of two courses from the graduate programs by paying the tuition fee.
- c) **Rejection:** Candidate Evaluation Commission's opinion and the relevant institute's department / department / program executive committee decided that they do not meet the announcement conditions, are not suitable for the program or fail in the exams, and the candidates who are not found suitable are not accepted to the program and their applications are rejected by the relevant EYK decision.

NOTIFICATION OF APPLICATION RESULTS

- **1.** Application results are announced on the date specified in the announcement via https://fint.firat.edu.tr/ and the official website of the University.
- **2.** Candidates accepted to graduate programs are asked to declare whether they will come for final registration by sending a confirmation message via https://fint.firat.edu.tr/ by the relevant institute directorate. Candidates who declare that they will come for final registration are sent an official acceptance letter in order to obtain a visa.

REQUIRED DOCUMENTS FOR FINAL REGISTRATION

- **1.** Final registrations will be made in person. Power of attorney will not be accepted during final registration.
- **2.** The documents required from the students who are entitled to final registration are as follows:
 - a) For applications to graduate programs; A copy of the undergraduate diploma and the undergraduate transcript approved by the Turkish foreign representatives or notary public, and the Turkish translation approved by the Turkish foreign representatives or notary public.
 - **b**) In applications to doctoral programs; A copy of the undergraduate and graduate diplomas, undergraduate and graduate transcripts approved by the Turkish foreign representative offices or notarized, and the Turkish translation approved by the Turkish foreign representative offices or notarized.
 - c) Photocopy of the passaport.
 - **d**) One photograph (taken within the last six months).

- e) Valid Turkish Language Certificate and Foreign Language Certificate, if any.
- **f**) Education Annotated Visa or document showing that you are an international student who will not be asked for a student visa within the framework of the principles set by the General Directorate of Security.
- **g**) For students who come with state scholarships within the framework of bilateral agreements, a document stating that their fees will be paid during the registration period.
- **h**) Diploma Equivalency Certificate for health fields.
- i) The original of the ALES, GRE or GMAT result document for the programs with the application requirement.
- **3.** If the students who have the right to final registration and who are given time due to missing documents do not submit their missing documents in due time or if it is understood that they submitted false or wrong documents during registration, they are dismissed from the institute even if their final registration has been made.
